Mr. Rolniak reported that he was applying for a U.S.D.A. grant which would require a 65% match from the township. The grant is for turn out gear for half of the firefighters. This would be around a \$10400 match from the township fire department budget. The board agreed to consider the grant for the 2007 budget year. A motion was made by Ms. Salmi supported by Mr. Suutala to authorize and sign the grant application. The motion carried.


