WATER RATE RESOLUTION

WHEREAS, the Charter Township of Ironwood Board finds it necessary to review and revise the rates established for payment of the expenses of administration, operation and maintenance of the Township Water System.

WHEREAS, the rates per month for services furnished by the Charter Township of Ironwood Water System shall be set at:

\$5.50 per each 1000 gallons of water used.

Readiness to Serve:

- Residential: \$25.00 per month per EDU (Equivalent Dwelling Unit)
- Commercial: \$30.00 per month per EDU (Equivalent Dwelling Unit)

Water Tap-in Fees:

5/8" or 3/4" line	\$1900.00
1" line	\$2000.00
1 1/4" line	\$2100.00
1 1/2" line	\$2300.00
2" line	\$2900.00
3" line	\$4700.00
4" line	\$7200.00
6" line	\$14800.00
8" line	\$25000.00

Miscellaneous Charges:

- Convenience on/off (during regular business hours) \$ 20.00
- Delinquent re-connect fee 150.00
- NSF check fee 30.00
- New account charge 15.00
- Contractor assistance \$50/hr. (1 man). \$80/hr. (2 men)
- After business hours – minimum 2 hours, \$75/hr./ 1 man. \$120/hr./2 men or actual cost.
- Non-refundable new meter fee shall be the actual invoiced cost of meter.

NOW THEREFORE, the Charter Township of Ironwood Board sets the rates and charges for services provided by the Township Water Department as stated above to be effective immediately.


